 - b. Contracts and other documentation supporting the request to import minerals
 - c. Title Documents, and Lease/permit (where applicant is not the owner of land)
 - d. Eight (8) Originals of a Survey Plan
 - i. Approved by the Director of Surveys, for State land
 - ii. Registered by the Director of Surveys, for Private land
 - e. Certificate of Incorporation / Certificate of Business Registration
 - f. Organizational Structure for Import operations
 - g. A letter from a recognized financial institution (indicating that the Applicant possesses the financial capacity to conduct the operations for which a licence is being sought)
 - h. Rehabilitation Plan (to be completed using template)
 - i. Certificate of Environmental Clearance (CEC)
 - j. Town and Country Planning Approval
 - k. Water Abstraction Permit (from the Water and Sewerage Authority)
 - l. Certificates and other qualifications of the Manager (indicating that the Applicant possesses the technical qualifications necessary to conduct the operations for which a licence is being sought)
